Instructions

1. The nominator completes SECTION A of this form.
2. If the nominee wishes to accept the nomination, s/he completes SECTION B and SECTION C of this form and returns Sections A, B, and C to the College office by email to ea@cnpbc.bc.ca or mail to Suite 840 – 605 Robson St., Vancouver, BC V6B 5J3, along with a biography of no more than two paragraphs.

Deadline

The College office must receive nominations on or before **4:30 p.m., Thursday, April 19, 2018.** Nomination Forms received after this time will be disregarded.

Eligibility

As set out at section 3 of the College's Bylaws, a registrant is only eligible for election to the board if:

1. s/he is a full registrant in good standing;
2. in the six (6) year period prior to the date of the election,
 - a. his or her registration has not at any time been suspended or cancelled for any reason other than non-payment of fees;
 - b. his or her authorization to practice naturopathic medicine has not at any time been otherwise restricted or limited by:
 - i. terms, limits, or conditions of a consent or undertaking given by the registrant under section 36 of the *Health Professions Act*, R.S.B.C. 1996, c. 183 (the "*Act*"), an order under section 35 or section 39 of the *Act*, or a deemed order under section 37.1 of the *Act*; and/or
 - ii. any terms, limits, or conditions attached to the registrant's registration under section 20(2.1) of the *Act*; and
3. s/he has not served as an elected board member for four (4) consecutive terms ending in the previous two (2) year term.
