## **Annual General Meeting and Election Reminder**

Just a reminder that the Annual General Meeting takes place 9:00-10:00 a.m. on Wednesday, May 4, 2022, online via Zoom webcast. Registration will begin at 8:30 a.m. This format has worked very well the last two years and we anticipate another engaging AGM.

The AGM will be followed by an education session from 10:15 a.m. to 12:00 p.m. The education session will feature Kelly Fujibayashi, Board Chair; Michelle Payne, Regulatory Practice Consultant; and Carina Herman, Registrar/CEO. They will be presenting new Standards of Practice for Naturopathic Physicians and how to apply them to practice.

Attendees will be eligible for 3 hours of continuing education credits for attending both the AGM and the education session. Credits can be applied towards Category A - AGM or Category G – Ethics, Professionals and Cultural Safety. Please use your discretion as to how to allocate the hours. The College will **not** be issuing certificates of attendance but will maintain a list of registrants who attended the AGM for its own record keeping purposes.

# ANNUAL GENERAL MEETING

## **Refund Clarification**

The College has received questions from several registrants recently regarding its policy on refunding registrants who elect to change their registration status mid-year, as opposed to during annual registration renewal.

### **Partial Refund: Practising to non-practising from July 1<sup>st</sup> to December 31<sup>st</sup>**

A full practising registrant who moves to non-practising status between July 1<sup>st</sup> to December 31<sup>st</sup> in a calendar year will be reimbursed for 50% of practising registration, certification and specialty renewal fees paid.

Reimbursement is subject to the registrant delivering their application for non-practising registration to the registrar on or before May 31<sup>st</sup> of the calendar year.

Section 56(10) of the College Bylaws sets out the basis for this reimbursement:

*A full registrant who becomes a non-practising registrant from July 1<sup>st</sup> to December 31<sup>st</sup> in a calendar year must be reimbursed 50% of the registration, certification and specialty*

*renewal fee(s) paid, if the application for non-practising registration for that period is delivered to the registrar on or before May 31<sup>st</sup> of the calendar year.*

**No Refund: Practising to non-practising from January 1<sup>st</sup> to June 30<sup>th</sup>**

A full practicing registrant who moves to non-practising between January 1<sup>st</sup> to June 30<sup>th</sup> in a calendar year will not be reimbursed for any fees paid. The College's Bylaws do not provide for reimbursement in this circumstance. The College appreciates that in the past there may have been some confusion on this issue but there is no reimbursement available under the current Bylaws.

**No Refund: Cancelling of practicing or non-practising license**

A practicing or non-practising registrant who cancels their license after payment will not be reimbursed for any fees paid. The College's Bylaws on reimbursements are balanced between supporting registrants and recognizing that the College is a registrant-funded non-profit regulatory body with extensive operational requirements.

## Notice re Tramadol

Registrants are reminded that as of March 31, 2022, Tramadol is part of Schedule 1 of the *Controlled Drugs and Substances Act* (CDSA) and is therefore no longer authorized for use by naturopathic doctors in BC. Per the College's Standards, Limits and Conditions for Prescribing, Dispensing and Compounding Drugs, Appendix E, CDSA scheduled substances are not permitted for use by registrants.

## New Drugs Update

The College's Pharmacopoeia and Diagnostics Referral Committee ("PDR") reviews new prescription drugs which become available on the Canadian market on an ongoing basis, and makes periodic recommendations to the Board regarding which drugs should be included or excluded from scope. The Board recently approved the PDR's recommendations for new drugs that came on the market up to the end of 2021, and the Scope of Practice for Naturopathic Physicians: Standards, Limits and Conditions for Prescribing, Dispensing and Compounding Drugs (the "Prescribing Standards") have been updated to reflect this.

Registrants are reminded to check the Prescribing Standards if they are ever unsure about whether a drug is within their scope of practice. Registrants who continue to have questions about prescribing and scope of practice after checking the Prescribing Standards are encouraged to contact the College directly.
